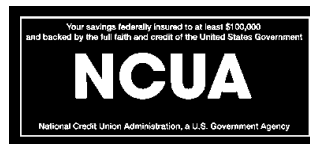

SMALL BUSINESS LOAN PROGRAM

**South Side Community
Federal Credit Union now
offers Small Business
Loans for start-up and
expanding small
businesses. You may be
eligible for a Small
Business Loan between
\$5,000 and \$35,000
(\$15,000 for start-ups).**

How to apply:

Complete a pre-loan application. If your business qualifies for this loan program then you will be notified within 3 business days to submit a loan application packet. Loan application packets may be picked up at the credit union or downloaded from www.southsidecommunityfcu.org. If loan packaging assistance is needed you may contact the Jane Adams Hull House at the Parkway Community House, 500 E. 67th St., (773)955-8027 or Chicago State University's Small Business Development Center, 9501 S. King Drive/BHS 601, (773)995-3938 or 3602. We will go through the process with you from approval to loan closing/disbursement. SMALL BUSINESS LOAN PROGRAM

Description:

Loans range between \$5,000 and \$35,000, depending on length of time in business.

Terms:

- Up to 5 years at prime + 2%
- Application fee: \$25
- Other fees: collateral filing and processing fees range between 3- 6% of loan amount.

Requirements:

- Must be a Credit Union member
- Business must be a legal entity located on Chicago's south side
- Must maintain \$100 share/savings account balance
- No bankruptcy in last 2 years
- 18 years of age or older
- 50% collateral coverage minimum

Eligible uses of loans include:

- Establishment of a new business
- Expansion of an existing business
- Job creation and/or retention
- Purchase of equipment, machinery, supplies or inventory
- Start-up operating costs and working capital
